

## E-Mobility and planning for FP7 – Survey results

The e-Mobility Steering Board is currently working on version 5 of the Strategic Research Agenda. This will be the version that will influence the first calls in the mobile and wireless area of FP7.

To help shape this document, feedback was sought from SMEs on how they would prefer to be involved in the 7<sup>th</sup> Framework Programme. **343** SMEs who had registered an interest in FP7 through the EPISTEP database were invited to take part in a short survey. This document provides the results of this survey.

Of the **343** SMEs who were initially contacted, 65 responded. This represents a **19%** response rate.

### 1. How are you currently involved in the 6<sup>th</sup> Framework Programme?
